<b>WHEREAS,</b> The traffic count just south of this intersection has grown by 39% over the last 10-years, and		
WHEREAS, The traffic count on CTH K east of this intersection has grown by 45% over the last 13-years, and		

WHEREAS, The traffic count on Swamp Lake Road west of this intersection has grown by 83% over the last 13-years:

THEREFORE, BE IT RESOLVED, by the Supervisors of the Town Board of Woodboro, Oneida County, that we strongly support the Wisconsin Department of Transportation, the Oneida County Highway Commission, and the Oneida County Board of Supervisors in allocating sufficient funding to implement the most effective intersection design for State Highway 51 and County Highway K. We urge that this project be prioritized and completed in a timely manner, with cost considerations not compromising the quality or safety of the solution.

BE IT FURTHER RESOLVED, that the Town of Woodboro direct the clerk to deliver this approved resolution to State, County, Town of Nokomis, Town of Cassian and to the individuals that signed the letter dated January 21, 2025.
